NOTICE OF REGULAR MEETING OF THE
TOWN OF SUPERIOR TOWN COUNCIL

Pursuant to A.R.S. Section 38-431.02, notice is hereby given to the Superior Town Council and to the public, that a Regular Meeting of the Superior Town Council will be held on Thursday, November 12, 2020 at 7:00 p.m. in the Superior Town Hall Auditorium, 199 N. Lobb Ave., Superior, Pinal County, Arizona. The agenda for this meeting is as follows:

Due to the impacts of the COVID-19 pandemic, which have prompted declarations of a public health emergency at both the state and federal levels, this meeting will be conducted using measures to protect public health. Members of the public are encouraged NOT TO ATTEND THE MEETING IN PERSON but instead to attend and listen to the meeting remotely by telephone.

7. CONSENT AGENDA

- 2. Approval of License Agreement between the Town of Superior (“Licensee”) and BHP Copper Inc. (“Licensor”). Licensor is the owner of a certain real property located in Superior, AZ. Licensor understands that the Licensee seeks to come onto the Parcels for the purpose of parking cars for a laser light show sponsored by the Licensee on October 31, 2020. Licensor desires to grant Licensee access to the Parcels for this light show.

In addition to the USDA/RD requirements, the preparation of a SVA and ERP will help improve the management of the water system and will increase the system's ability to respond to emergencies.

Approval of Notice of Request for Proposals for a General Plan Consultant to provide best practices and technical expertise to prepare a plan which includes the statutorily required General Plan Elements.
